We have an exciting opportunity in the Business, Public Sector and Transport Directorate.

The Business, Public Sector and Transport Directorate is delivering a range of energy efficiency and emissions reduction programmes across several distinct non-domestic sectors: business, public sector, transport and regulatory programmes. The aim of the programmes in this directorate is to support decarbonisation of industry, commercial and public buildings, and transport, and deliver regulatory programmes which support both domestic and non-domestic objectives. Key programmes in this area include energy network and knowledge supports such as the Large Industry Energy Network, Public Sector Partnership, and SME Energy Academy. Capital programmes such as the Public Sector Pathfinders, EXEED, Support Scheme for Renewable Heat (SSRH), Support Scheme for Energy Audits, and Non-Domestic Microgeneration Scheme support a wide cohort of non-domestic clients with investments. In the transport sector we deliver grants for private and commercial electric vehicles, and grants for home and apartment EV charging, demand generation and information campaigns, as well as providing advice and support to Zero Emissions Vehicles Ireland (ZEVI). A sub-section of the Directorate is designated as a Regulatory Body and Authority. Regulatory areas currently include Market Surveillance Authority relating to energy labelling and ecodesign, and the Energy Efficiency Obligation Scheme (EEOS).

## THE ROLE PROFILE

The role of Programme Manager – Support Scheme for Renewable Heat will sit within the Business Supports and Transport Department. The programme will be closely aligned with our SME and Large Industry programmes and will support the achievements of national emission reduction targets in Heat, specifically in Industry and Non-Domestic Buildings.

The successful candidate for this will report to the Head of Business Supports and Transport.

This position will play a key role in the above Department. The Support Scheme for Renewable Heat (SSRH) is a significant national support to the non-domestic sector (€300 million funding targeting 1.3TWh of renewable heat). The SSRH offered grants for heat pump installations, and a 15-year tariff for biomass or biogas installations to a wide range of non-domestic heat users in buildings and industry. The SSRH programme has recently been enhanced and there is significant demand through the scheme, which also supports district heating projects. This is an exciting and challenging role to lead a scheme making a significant contribution to Ireland's emissions targets.

#### **KEY RESPONSIBILITES**

The responsibilities will include, but not limited to, the following:

- Lead and manage the Support Scheme for Renewable Heat, supporting clients with applications for funding, and delivering the targeted renewable heat and emissions reduction from the programme.
- Lead and manage the SSRH Programme including the development and delivery of annual business plans, budget planning and management, team and resource management, ongoing reporting against KPIs, risk management, development of marketing and promotional material, and programme strategy development.
- Operational management and oversight of the SSRH, including ensuring efficient application and payment processes, developing and enhancing service, supply chain feedback and training, and enhancement of guidance, tools and templates.
- Deliver ongoing reporting obligations to the Department of the Environment, Climate and Communications (DECC) including the SSRH Annual Tariff Review and SSRH Annual Review as required.
- Support DECC colleagues with ongoing oversight and operational requirements including state aid, reporting and budgeting.
- Enhance and reform the SSRH operational processes, to ensure a clear and efficient customer journey with a proportionate controls and governance.
- Effective management of resources including staff performance management and development, external consultancy, and outsourced Business Process support
- Support SEAI in providing key advice to Dept of Environment, Communications and Climate (DECC) and other relevant government departments in the formulation, assessment and delivery of heat policy supports and regulatory measures.
- Play a key role as subject matter expert on a national level, inputting into national initiatives, working groups, standards, and guidance development.
- Manage, develop and present at internal and external events focussed on engaging businesses in energy efficiency and decarbonisation, specifically the adoption of renewable heating.
- Work closely with SEAI colleagues across the Business, Public Sector and Transport
  Directorate and other Directorates to collaborate and share knowledge and
  approaches.
- Assist the Head of Business Supports and Transport in ensuring that SEAI are
  effectively supporting businesses with energy efficiency and emissions improvements
  at scale in line with government objectives and targets.
- Participate and represent SEAI in national, European, and international committees, as required.

To ensure that activity peaks within the Department are addressed in a proactive manner, it is expected that the candidate appointed to this role will need to be flexible in terms of working hours during these periods.


The knowledge and skills required include but are not limited to the following:

- A capacity to foster a positive working relationship with colleagues and external stakeholders; to work in multi-disciplinary teams and to network effectively.
- Ability to think strategically and develop service offerings from concept to implementation.

- Strong proactive approach to achieving results, including managing scope, time, risk assessment, cost and quality.
- Flexible approach to problem solving and decision making to ensure the best solution is achieved focusing on the need for greater efficiency and effective delivery.

#### **ESSENTIAL REQUIREMENTS**

The successful candidate must be able to demonstrate:

- Degree level (or greater) or equivalent professional qualification in a relevant technical discipline such as engineering or science.
- Minimum 6 years' experience of working in this or a related sector or in a similar role (can include post-graduate studies)
- Experience of project management and demonstrated ability to delegate and manage a team.
- Strong written and verbal communication skills, including report writing, presenting, public speaking.

### **DESIRABLE REQUIREMENTS**

- Working knowledge or renewable heating technologies including heat pumps, biomass and biogas heating solutions.
- Knowledge of the energy sector, particularly in energy efficiency and renewable energy in business and industry, would be a distinct advantage.
- Delivery of capital grant programmes to business.
- A qualification in project management.

There may be a requirement for the successful candidate to further develop specialist knowledge and expertise relevant to the role. Training will be encouraged (formal and informal) and supported where required.

The SEAI may invite candidates to a second-round interview and to undergo further assessment, including the use of psychometric assessment if so required. Interviews may take place in person or online, as appropriate.

### ANNUAL LEAVE

The annual leave allowance will be **30** working days a year, based on a five-day week and is exclusive of public holidays. leave is prorated for part time.

#### **WORKING WEEK**

Weekly working hours will be, on average, not less than 41.25 hours per week (**35 hours net of rest breaks**). Pro-Rated for part-time roles. Additional hours may occasionally be required within reason to meet the requirements of the role. The salary for this role incorporates payment for any additional hours, and therefore no additional payment will accrue. The SEAI Blended working policy allows for flexible start and finishing hours, currently start times between 8 –10am, and finish times between 3:30 – 6pm.
