Electricity - from 1/10/2017 the Public Service Obligation (PSO) levy was increased as follows: From €20.73 to €26.55 per customer per month for small commercial customers (max import capacity < 30kVA) and from €3.33 to €3.64 per kVA for medium and large customers (max import capacity >= 30kVA). Commercial / Industrial Fuels Comparison of Useful Energy Costs for Space Heating

Notes:

- 10. Use manufacturers recommended fuel for each appliance.
- 11. Delivered energy costs quoted are for the conditions stated overleaf.
- 12. Efficiencies quoted are bands of typical seasonal heating efficiencies
- 13. If a night rate electricity meter is installed and if the heat pumps are run during the night, a unit cost of approximately half that specified can be assumed in the calculations for heat pump running costs.
- 14. Seasonal Performance Factor is defined as the ratio of heat output from the heat pump and the electricity supplied to the heat pump over the heating season. SPF's quoted assume heat pumps are used in conjunction with low temperature systems such as underfloor heating.
- 15. The Home Heating Appliance Register of Performance (HARP) database contains exact performance specifications of the proposed/installed appliances. www.seai.ie/harp
While HARP is not used in non-domestic Building Energy Rating (BER) it still gives a useful indicator of appliance efficiency/SPF for the purpose of commercial fuel cost comparisons.
